

## Violet Township Board of Trustees

May 5, 2010

### Regular Meeting

Chairman Dunlap called the meeting to order at 7:30 p.m.

Mr. Smith called the roll and Mr. Dunlap, Mr. Myers and Mr. Weltlich were present. Other Township employees present were: John Eisel, Fire Chief; Assistant Chief, Doug Barr; Bill Yapple, Director of Operations and Greg Butcher, Township Engineer.

Mr. Dunlap asked the audience to join with him in the Pledge of Allegiance and to remain standing for a moment of silence in honor of those that safeguard our freedoms around the world and our public safety officers here at home.

**Mr. Weltlich moved to adopt the minutes of the Regular Trustee meeting of April 21, 2010 and without public reading. Seconded by Mr. Myers. Roll call vote: Mr. Weltlich, yes; Mr. Myers, yes; Mr. Dunlap, yes. April 21, 2010 Regular Trustee meeting minutes approved. 3- 0.**

#### **Departmental Reports:**

##### **Fire Department**

Chief Eisel had an updated map of the outdoor warning sirens in regards to locations. This shows current status. It looks like there are two warning sirens available. John Kochis is going to pursue this to see what the Commissioners commitment is. Chief noted that the radiuses on the map are one mile radiuses.

Chief Eisel passed out copies of several thank you letters that the Fire Department had received.

Chief Eisel reported he was in Washington last week for the Congressional Legislative Conference.

Chief Eisel would like to declare the portable radios that were replaced the first of the year as excess equipment and offer to other government agencies as we are permitted to do. The best value they can find is \$400.00. **Mr. Myers made a motion to adopt Resolution 2010-0505-03 – Declare Excess Equipment. Seconded by Mr. Weltlich. Roll call vote: Mr. Myers, yes; Mr. Weltlich, yes; Mr. Dunlap, yes. Resolution 2010-0505-03 is adopted 3-0.**

**Regular Meeting**

Chief Eisel reported they did receive their equipment from Paratech for the technical rescue truck. The equipment is not mounted yet.

Mr. Dunlap asked if we needed to tell our EMA Director if we need two or three sirens. Chief Eisel said they now have one earmarked for us if we want it and a possibility we could end up with two. Mr. Dunlap suggested letting them know we are interested in the two.

Mr. Myers asked about a fire on Amanda Northern Road. Chief Eisel said the first fire was the barn on Friday and then early morning hours Saturday morning the first house south of there was on fire. The crews checked everything out. There was no communication from the fire Friday afternoon to the fire that occurred Saturday morning. There was no link from the original fire to the second fire. They are keeping an eye on it. Mr. Weltlich asked who investigates this. Chief Eisel said that we do and we can call in for assistance if need be. They follow a certain criteria.

**Township Engineer**

Mr. Butcher reported mowing is ongoing. They are mowing every day. Next week they should get into the road right of ways.

The pavement maintenance is still being reviewed by Greg and Mr. Dunlap.

Dog Park is still being worked on. Some grading has been done.

Mr. Butcher had a conversation with Jeff Baird with the County Engineers office on the Waterloo Road bridge and the survey is complete, the design is on going as is the cost estimate and it is up to us to prepare the applications. We need to determine the priority of this project.

Mr. Butcher reported that a few employees from Soil and Water stopped by to see him regarding Saturday, May 15 prescription drug drop off so that everyone can be on the same page. Soil and Water will be there, Sheriffs office, community watch folks. They want to have a drive through. Mr. Butcher gave them a tour of the building to show them where everything was.

Mr. Butcher said he has been working on the reformatting of the Access Management Manual. It has been in place for about 3 years now. His goal is to have it located here centrally so that whenever someone wants something everyone knows where it is. We will also put it on our website.

Next Tuesday we will bid the Busey Road Culvert Replacement project. Mr. Butcher has been in contact with various utility companies. He wants to make sure we are all square and there are no surprises. Mr. Butcher reported there was very little interest in the 'plan holders' project? It is about a \$100,000.00 project. About 10% would be the paving cost of the project. There has been one set of plans picked up as of this afternoon. Three others are interested. Mr. Weltlich suggested sending an email to the Associated General Contractors Association.

Mr. Butcher had a meeting last week on Safe Routes to Schools. They talked about a spring event that the Trustees, Fire Chiefs to participate in the 'Walking School Bus' which is next week. John and Gary will participate so far. This is an opportunity to put this in front of people and is part of our commitment to the State of Ohio.

## Regular Meeting

Mr. Weltlich mentioned that at the Pickerington City Council meeting they passed a resolution acknowledging that the Township will absorb any and all overruns for the Safe Routes to School Program. Mr. Butcher has not had any discussion on this. This is natural for Phase 1 because all of the work is in the Township. Mr. Butcher will speak to the City regarding this. Mr. Yaple added that they are doing a lot of the design and drawings for this.

Mr. Weltlich asked about the Waterton Drive tree in the right of way that Mr. Yaple and Mr. Butcher were going to look at. Mr. Yaple said they had looked at the documents but they have not heard any more from this resident. Mr. Butcher doesn't think there is any more action that can be done on staff's part.

Mr. Meyers asked if the summer help college kids were back on.

### Director of Operations

Mr. Yaple reported we have received the court order to transfer cemetery funds that resolution has been completed on. Mr. Smith has verified with the County Auditor that we were ok to make that transfer and those documents will go as soon as the check is ready to go from us to the City of Pickerington. This will then be out of our funding.

We had another request for yearbook ads from Bloom Carroll. We have a few motions to do for Pickerington North and Central if we want to add Bloom Carroll to that list.

Mr. Yaple passed out the flyer about the prescription drug drop off. A public service ad was run. Mr. Dunlap saw big banners by Setan Parish that shred day was at the same time on May 15<sup>th</sup>.

Pickerington Lions Club has requested attendance at an Open House the Pickerington Senior Center on May 27<sup>th</sup> from 7 – 830 pm for a membership drive.
